Subject: Poll shows passenger rail and rail safety a priority for Missouri voters

Jefferson City, MO – Today, the SMART Transportation Division's Missouri State Legislative Board released the results of a survey that shows 76% of Missouri residents strongly support the continued funding for Amtrak. Missourians also support trains being operated with a minimum of two crew members on all trains, with no exceptions.

A majority of Missourians have a desire for additional passenger rail service. Fifty-Five percent of those questioned said that they would like to see passenger rail extended to other communities throughout the state.

The two-person crew question is similar to one that was polled in March of this year, in an effort to get a better, more accurate feel of how Missourians view the safety of trains. The Federal Railroad Administration (FRA) recently released a proposed rule which would require most trains to operate with a minimum of two crew members, except for where the FRA believes a single operator does not pose a significant safety risk for rail employees, the public, or the environment. When asked which best fits their views on rail safety, a clear majority (70 percent) of Missouri likely voters favor 'no exceptions' from requiring all trains have a minimum of two crew members operating in Missouri. Only five percent believe the FRA should not regulate crew size.

"The serious safety risks posed by single-person freight train operations became tragically clear during the summer of 2013 when a runaway oil train barreled into Lac-Mégantic, Quebec, destroying half the town and killing 47 people," said Jason Hayden, Director of the SMART TD Missouri State Legislative Board. "Missourians have consistently shown that they understand the risk of single-person operators on freight and passenger trains, and want to make safety a top priority by requiring all trains in the state to be operated by a crew of at least two people, with no exceptions," added Hayden.

The poll was conducted October 27th – November 1st, 2016 of 508 random likely 2016 general election voters using both cell phones and landlines by DFM research of St. Paul, MN. The Transportation Division of SMART (International Association of Sheet Metal, Air, Rail and Transportation Workers) represents freight and passenger rail operating employees in Missouri and across the country.



Executive Summary

Missouri voters, regardless of who they support for president, strongly support a federal regulation requiring a crew of two on all freight trains. Currently the Federal Railroad Administration (FRA) is in the final stages of promulgating a two-person crew regulation. Missouri voters are strongly (70 percent) in favor of a rail regulation that has 'no exceptions' when it comes to crew size; only five percent believe no regulation is needed. The survey was conducted between October 27 – November 1 consisting of 508 random Missouri likely voters using both landline and cell phones.

Support level for a 'no exceptions' FRA regulation requiring a crew of two on all freight trains has strong widespread support among all key demographic groupings:

- No difference on gender, both men and women support 'no exceptions' at 70 percent.
- Very little difference on age, ranging from 68 percent 'no exceptions' for under age 40, to 71 percent between the age of 40-64.
- Voters with a high school education are slightly more likely to support 'no exceptions' than college educated (72 and 68 percent).



The data also clearly shows that crew size, which impacts the safety of rail employees, the public and the environment, is not a partisan issue.

- Only seven percent of self-identified Republicans, and nine percent of Donald Trump voters believe the FRA should not regulate crew size, and that no regulation is needed. This compares favorably to five percent of Democrats and two percent of Hillary Clinton voters who believe no regulation is needed.
- Democrats are generally more supportive of the 'no exceptions' rule; yet 68 percent of Independents and 63 percent of Republicans also favor the 'no exceptions' rule. This strong level of support across party lines shows that when it comes to rail safety, Missouri voters agree that is makes good sense to have at least a crew of two on all freight trains.

In addition to the key question regarding the FRA regulation, the survey also shows strong support to expand or maintain Missouri Amtrak service and to support current levels of national Amtrak funding.
